MEMORANDUM OF OPTION AND PURCHASE AND SALE AGREEMENT

THIS MEMORANDUM OF OPTION AND PURCHASE AND SALE AGREEMENT (this "Memorandum") is made and entered into as of ______, 2021 (the "Effective Date"), by and between PDC SACRAMENTO LPIV, LLC, a Delaware limited liability company ("Optionee"), and THE CITY OF ROSEVILLE, a municipal corporation ("Optionor"), with respect to the following Recitals.

- A. Optionor is the fee owner of approximately 236.26 acres of unimproved land located in the City of Roseville, County of Placer, State of California which is more particularly described in Exhibit A attached hereto (the "**Property**").
- B. Optionor and Optionee have entered into that certain unrecorded Option and Purchase and Sale Agreement ("Option") dated as of _______, 2021, on the terms and conditions set forth in the Option.
- C. Optionor and Optionee desire to confirm and evidence the Option in the Official Records of Placer County, State of California (the "Official Records").
- **NOW, THEREFORE**, in consideration of the foregoing Recitals (which are incorporated herein by this reference), and in consideration of the mutual promises and covenants contained in the Option and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Optionor and Optionee hereby agree as follows:
- 1. <u>Definitions</u>. Initially-capitalized terms set forth in this Memorandum and not defined herein shall have the meanings ascribed to such terms in the Option, unless the context clearly indicates otherwise. All references in the Option or in this Memorandum to the "<u>Option</u>" or the "<u>Agreement</u>" shall be deemed to refer to the Option as supplemented by this Memorandum.

- 2. Option of the Property for the Option Term. Optionor and Optionee hereby ratify and confirm that as of the Effective Date Optionor has granted to Optionee, upon and subject to the terms more particularly set forth in the Option, an option to purchase all or any part of the Property on the terms set forth in the Option. The Option is for a term (the "Option Term") of Ten years, beginning on the Effective Date.
- 3. **Governing Law**. This Memorandum shall be construed in accordance with the laws of the State of California. The parties hereto consent to jurisdiction and venue in Placer County, California.
- 4. <u>Conflicts</u>. In the event of any conflict between the terms and conditions of this Memorandum and the terms and conditions of the Option, the terms and conditions of this Memorandum shall control.
- 5. <u>Amendments</u>. This Memorandum and the Option may be amended by a written instrument executed by Optionor and Optionee.
- 6. **Exhibits**. All exhibits attached to this Memorandum are incorporated herein and made a part of this Memorandum by reference.
- 7. <u>Entire Agreement</u>. This Memorandum, the Exhibits attached hereto and the Option (and exhibits attached thereto) are the entire agreement between the parties regarding the subject matter contained herein and supersedes all prior or contemporaneous agreements, representations, and undertakings of the parties.
- 8. <u>Counterparts</u>. This Memorandum may be executed by the parties hereto in any number of counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same agreement. The signature page of any counterpart may be detached therefrom without impairing the legal effect of the signature(s) thereon provided such signature page is attached to any other counterpart identical thereto except having additional signature pages executed by other parties to this Agreement attached thereto.
